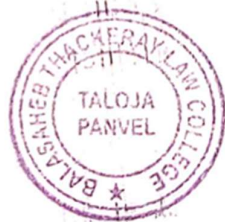

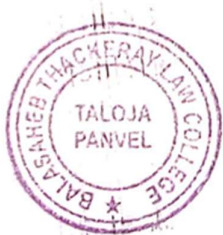




1) Restricted entry of Automobiles

The BTLC has restricted entry of Automobiles, it means:

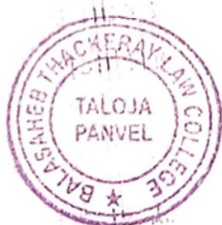



4. Ban on Use of plastic

Initiatives to Implement the Green/Plastic free campus

The following infrastructure has been established, and the following actions are being carried out, as part of the Institution's commitment to managing its campus in compliance with the Clean and Green Campus Policy:

✚ Landscaping with Trees and Plants:

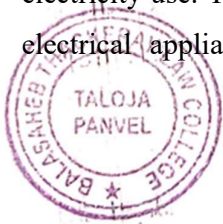
In accordance with the Clean and Green Policy of Balasaheb Thackeray Law college, Taloja , Navi Mumbai the college works to grow a wide variety of attractive ornamental plant species and medicinal trees both inside and outside the campus. The College organize tree planting drives, which are regularly undertaken by NSS Unit.

✚ Plastic Free campus:

Single-use plastics are totally prohibited in all areas of Balasaheb Thackeray Law college, Taloja, Navi Mumbai, including the canteen, classrooms and the laboratories. The college provides eco- friendly alternatives such as stainless steel washable and reusable tumblers, and the canteen is required to serve food only on glass, or stainless-steel plates. The use of single-use plastic is completely prohibited in college campus and in all significant college meetings and events organized according to college administration policy.

✚ Installation of energy-efficient equipment and alternative energy sources:

The college installed a solar energy plant on the roof of its main building. Since these solar panels were installed, MSEDCL's electricity bills have significantly decreased. The solar panels' energy production is connected to the MSEDCL power grid, which receives the power generated by the panels in exchange for a subsidy from the MSEDCL for the college electricity use. The college is committed to installing energy-saving and environment friendly electrical appliances. In order to reduce energy usage, most tube lights and lamps in

classrooms, Library, moot court and passages have been replaced with compact fluorescent bulbs or LED bulbs.

Boards are displayed everywhere to switch off the light's seminar hall, classrooms, and library when not in use.

Rainwater Harvesting for water conservation:

Through rainwater harvesting, the college makes sure that rainwater is conserved. Rainwater from the roof top outlets is transported via pipelines attached to the big water harvesting tanks. Rainwater collected in the tank is used to irrigate the plants in the medicinal Garden. In order to utilise harvested rainwater for irrigating the plants of medicinal garden, the college built big tanks next to the medicinal garden. Furthermore, the excess rainwater from these tanks is transported to the soak pit in order to replenish the groundwater.

Process of waste management:

Balasaheb Thackeray Law college, Talaja, Navi Mumbai disposes of the garbage produced at the college with complete accountability and after taking all necessary safety measures. The agreements for waste management are made with various agencies.

By separating waste into dry and wet categories using the designated dustbins, which are placed in strategic spots and given to the local municipal truck, the campus is kept clean and environmentally friendly. Vermicomposting is utilised to process all of the solid waste that is gathered from the campus. Such vermicompost is intended for use in gardening. A stack of one-sidedly printed paper that is used for routine rough paper work. Awareness is made among the students to reduce their electronic waste and to make arrangements for environmentally friendly disposal. Display boards to Encourage Environmental Awareness in College Campus:

Numerous boards have quotes that support environmental ethics and awareness, such as reducing air pollution, eliminating plastic on campus, conserving energy, recycling resources, and planting trees, displays about nature conservation, plantations and other topics are

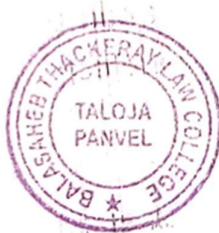

In response to the growing environmental concerns and the need for sustainable practices, the leadership at BTLC has undertaken a comprehensive initiative to transform its campus into an eco-friendly heaven. This multifaceted approach encompasses a range of strategies, each contributing to the overall goal of creating a green and sustainable environment.

1) Restricted Entry of Automobiles:

BTLC has implemented a stringent policy limiting the entry of automobiles on campus. While exceptions are made for staff residing far away, students are entirely prohibited from using personal vehicles. Even the limited staffs with vehicles are permitted to park at designated areas near the entrance, preventing noise and air pollution within the campus.

2) Use of Bicycles/Battery-Powered Vehicles:

Promoting sustainable transportation, BTLC encourages the use of bicycles or battery-powered vehicles. This policy is especially enforced for students, limiting their options to these eco-friendly modes of transport. Staff members are also expected to adhere to these guidelines, with bicycles restricted to parking zones near the entrance.

3) Pedestrian-Friendly Pathways:

The pathways within the campus are meticulously designed to be pedestrian-friendly. Wide tar roads, approximately feet in width, adorned with trees on both sides, create a serene and well-maintained environment. 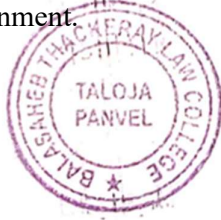
