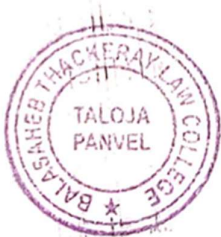

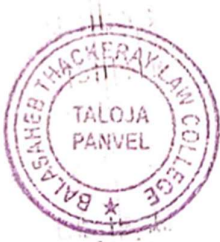

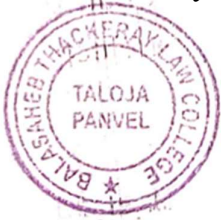
### **Institutional Efforts towards inclusive environment for Linguistic Diversities.**

The following are some of the ways the institution has carried out programs for gender balance and equity: - Gender Audit; co-curriculum; curriculum activities; and amenities for women on campus.

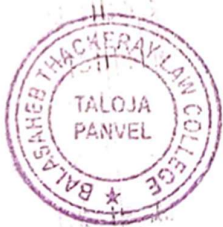

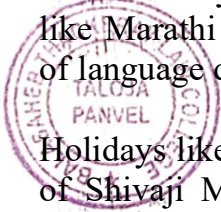
